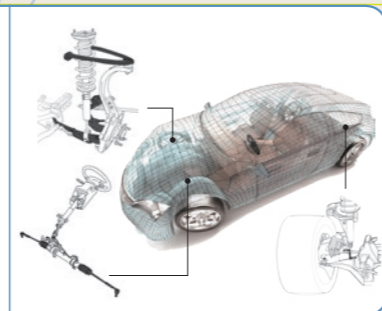
Industrial Machinery Business (Other)

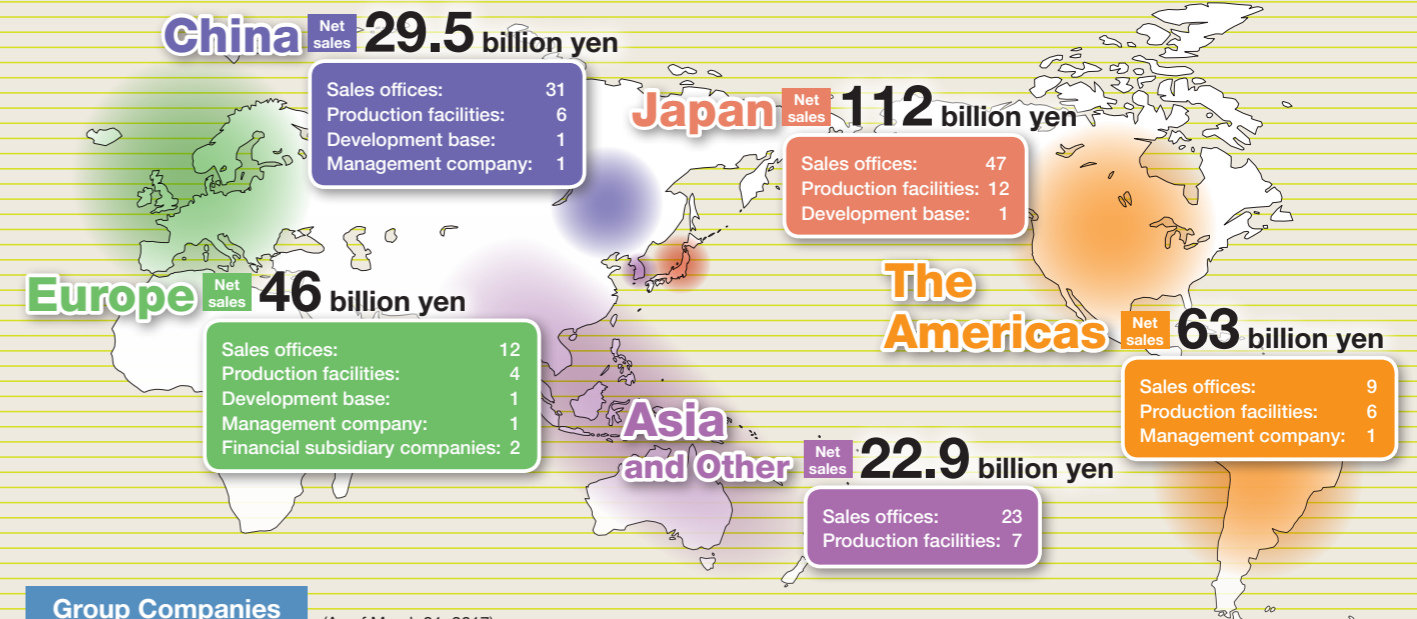
Automotive & Transportation Business

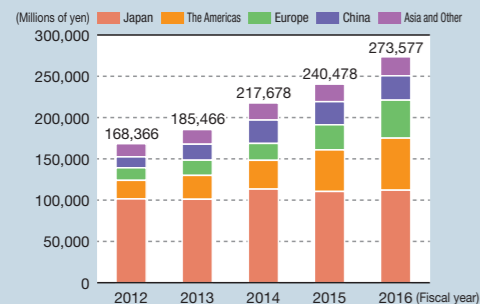

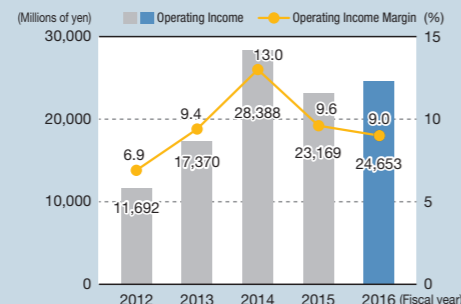

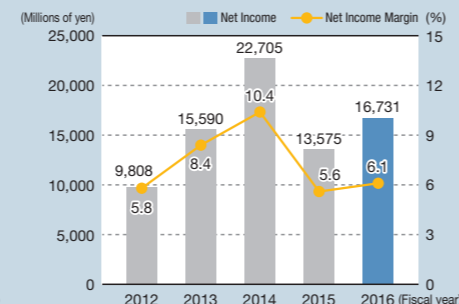
Net Sales



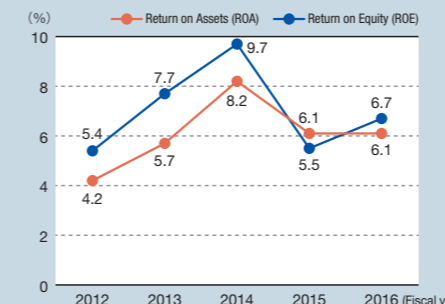
Operating Income and Operating Income Margin



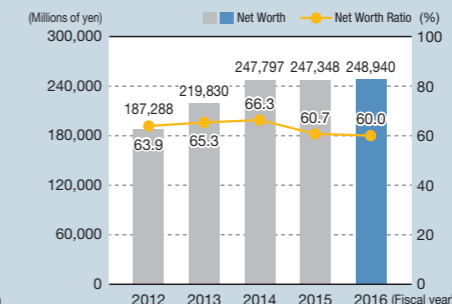
Net Income Attributable to Shareholders of THK CO., LTD., and Net Income Margin
