4. Due Diligence Process and Risk Assessments

Each THK Group company conducts human rights efforts led by their human rights personnel, with the Compliance Committee, which is headed by the President, at the center of these efforts. Based on this framework, THK Japan deliberates and shares information in accordance with the Group's due diligence process for human rights.

As part of executing this process, the THK Group once again performed the following risk assessments in 2024.

(1) Risks within the THK Group

The following risks were identified as a result of the Group's internal due diligence process.

- Harassment
- Employee labor issues (overtime work, unpaid wages, etc.)
- Bribery

The THK Group has conducted internal training in order to prevent or mitigate these risks. In addition, we provide a reporting structure for employees at each Group company so that we can identify the emergence of risks early and take corrective action.

Furthermore, THK Japan and Group companies in Japan conduct a compliance survey annually to understand the work environment.

(2) Risks within the supply chain

As a result of the Group's internal due diligence process, no human rights violations have been identified within the THK Group supply chain at the present time.

However, it is clear that the THK Group overall needs to continue its efforts toward ethical procurement.

The THK Group requests the cooperation of its primary suppliers in its human rights initiatives, and it has also made efforts to raise their awareness around human rights issues through means such as distributing the THK Group Supplier CSR Procurement Guidelines and THK Group Human Rights Handbook.

The THK Group will continue to provide information to and have discussions with its suppliers to gain their understanding and cooperation.
