THK CO., LTD. ("THK") hereby announces that, at a meeting of the Board of Directors held on February 14, 2024, THK decided to submit a proposal regarding partial amendments to the Articles of Incorporations to the 54th Ordinary General Meeting of Shareholders to be held on March 16, 2024.

1, Reasons of amendments

In order to properly correspond to the increasingly severe business environment and to improve the effectiveness of the Board of Directors' functions, Article 14 (Convocation), Article 15 (Chairperson), and Article 31 (Convenor and Chairperson of Meetings of the Board of Directors) of the current Articles of Incorporation shall be amended.
