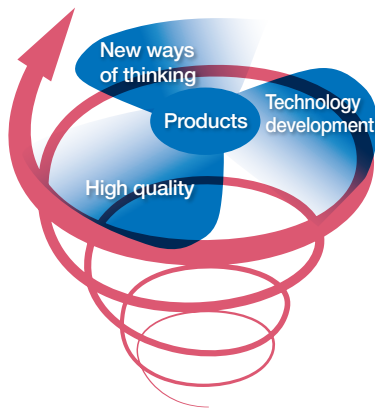
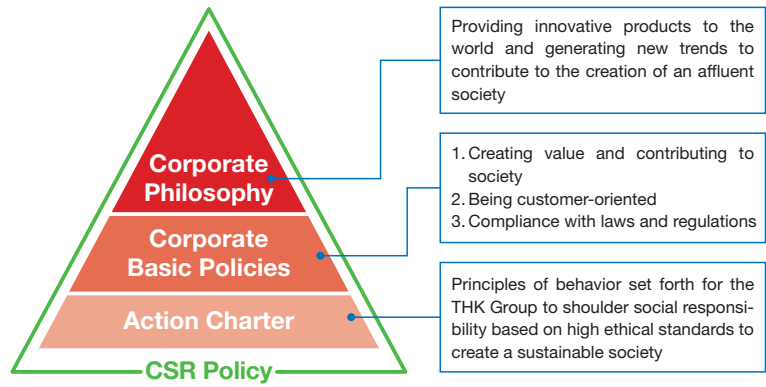


THK's CSR Policy
